Governor Gibbons, to Speak at Dec. Luncheon

Governor Jim Gibbons will be speaking at our next luncheon on December 3rd, 2007 at the Hofbrau-house Las Vegas.

Governor Gibbons has been under attack for announcing the necessary budget cuts that will be needed due to the short falls in revenue. As expected Democrats have been quick to criticize and short on ideas on how to balance the budget.

Governor Gibbons, however, already has come under fire, although he will not announce before January specifically where he will cut

state spending by more than \$285 million.

Governor Gibbons has exempted public education, the prison system, public safety agencies and children's programs from any cuts.

Judicial Obstruction??

An attempt was made by Homeland Security to send out “no- match” letters to business entities that hire a variety of potentially illegal aliens. These “no-match” letters would question social security numbers that were deemed to be incorrect. This appears to be a logical approach in an effort to correct a problem and in effect uncover irregularities in the use of social security numbers which were fabricated, stolen or simply created by various unauthorized methods. My conclusion as a Retired Public Accountant in continuous practice for over 40 years leads me to conclude that this process was long overdue. The 9 million “no-match” letters were never sent. A preliminary injunction at the direction of US Judge Charles Breyer said the plan “would result in irreparable harm to innocent workers and employers.” He based his ruling on the conclusion that enforcement of the law would place a financial burden on the employers and result in the firing of legal workers because of errors.

During the years of my Public Accounting Practice which included extensive Businesses and Professional Organizations, the problem of incorrect social security numbers and names occurred on a routine basis. The various firms’ human resources, bookkeeping and accounting personnel responded to inquiries by the Internal Revenue Service and forwarded the correct information to them. Under no circumstances was an employee terminated because of erroneous reporting. None were fired and the correct information was forwarded to the proper authorities. Legal workers experienced no problem contrary to the assertion of Judge Breyer that employees would be fired because of errors.

Finally, the Bush Administration first serious attempt to control our borders was struck down by our Judicial System.

This brings us to the aspect of the Real ID Act containing one particular provision that would establish national standards for state issued driver’s license and non-driver’s identification cards. One wonders what is so intrusive of this particular requirement since we all are obliged to obtain a social security number as soon as we begin to breathe. The House of Representatives passed a spending bill with the Real ID rider by a margin of 368 to 58. The Senate approved it by a vote of 100 to 0. The President signed it into law on May 11, 2005. Clearly our legislative and executive branch of our government was in accord with this particular law. The US government has included provisions to provide the issuance of these Real ID cards to the poor at no cost. Although it appeared that the initial problems with the Act were resolved, it was determined that enforcement would be postponed for an additional two years to December ‘09.

- We must as a government protect and preserve our sovereignty. The Real ID Act may be considered as an effort in that direction.
